Please Read the Terms and Conditions

1. Sailing can be a dangerous sport. Remember it is your responsibility to ensure your own safety, that of your crew and other persons and property, whilst sailing, rigging, unrigging or in any activity associated with the Wave Program
2. To access property of Royal Prince Alfred Yacht Club or Palm Beach Sailing Club you are required to be a member of the relevant club or accompanied by a member of that club.
3. All persons sailing on a Wave MUST wear approved Bouyancy Vests.
4. All persons chartering a Wave agree to pay a \$500 damage excess should the boat they are operating be damaged or causes damage to other property or persons.
5. Privacy; the Wave Program will periodically use information from the registration and certification processes of the Wave Program to send electronic messages to those that are part of the program. By being part of the program you agree to this happening. You also understand that while commercial security practice and certificates are utilised by the Wave Program and the Sailing Site, it is solely the responsibility of the user to continue with any transaction over the internet.
6. You agree to obey and follow any instruction from any Club Official, Race Official or Representative of the Wave program.
7. You agree to adhere to the Code of Conduct as expressed by Yachting Australia and available on the YA website, The Hobie Association of NSW and The PBSC Web site.
